I beg to state that, I the undersigned aged about 50 staying in a rented house at type II Ayin Leikai Langol, under Uripok Constituency about 47 Km South from Saikul-PS.

That, I, Tingcha Chongloi wife of (L) Jiten Chongloi and my family reside there. Following 3 May 2023 violence in Imphal valley we all were evacuated from Imphal leaving behind all the household items. Till 12 December 2023 sources informed that it was safe.

However, from a reliable telephone source received on 10<sup>th</sup> Jan. 2024, some unknown miscreants in collusion with one Naobi (Owner of the house) have vandalised my rented house and looted all the moveable and valuable items including all the household items worth about 22 Lakhs as per own assessment.

The incident is suspected to have occurred on the 2<sup>nd</sup> January 2024.

The list of properties loss or damaged are mentioned in the annexure (enclosed).

It is, therefore, requested to kindly register a regular case and take necessary legal action against the culprits according to law.
