I have the honour to state that, On 04-05-2023 at around 3:30 pm some unknown suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our locality at Khongsaiveng Laiphamkhonou Imphal/ East -Dist. Manipur about 45 km South from Saikul-PS. they vandalised rented house and looted all the moveable properties and my house along with all the remaining items into ashes leaving us homeless. Fearing lost of live burnt down self along with my family left our home and now we temporarily stayed at Thangkanphai Village Relief Centre Kangpokpi District, Manipur. Due to lack of knowledge I report the incident in time. The list of properties destroyed or Annexure (enclosed). The Approximate value of destroyed loss are mention in the at about Rs.78,47,100/- (Seventy eight lakhs Forty seven thousand or loss properties is calculated and one hundred).

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
