

on 04-05-2023 by the violent Meitei Radical mobs at National Game Village,
Zone - II. at around 7:00 PM.

Sir,

I have the honour to state that I owned a plot and house at National Game Village
(NGV) Zone - II under Patta No. 94 (old) and 3146 (new), Dag No. 141 measuring an area of
1740.

That, my house / building which was constructed at my plot was burnt and looted all
my belongings by the violent Meitei Radicals mobs on dated 04-05-2023 after the communal
ethnic clashes erupted between the Kukis and Meitei communities on 3rd May 2023. As such,
I became one of the victims of the ethnic clashes.

That, the Pucca building is worth more than 80 lakhs and properties burnt and looted
were more than 30 lakhs.

I, therefore, request you to kindly register me Zero FIR in this connection as I am
unable to lodge the complaint at O.C. Lamphelpat, Imphal West as it is risky and not possible
to lodge at Lamphelpat at the risk of our lives Hence this application.
