Subject : Report.

Sir,

I have the honour to state that, on 04-05-2023 at around 3:20 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-2000 persons carrying Sophisticated weapon forcefully attacked and entered our locality at Khongsai veng, Imphal East Dist. Manipur about 42 Km South from Saikul -PS, after looting all the moveable properties and cash, they burnt down my house alongwith all the household properties including Furnitures, Electronic items, Utensils, Clothes, Books and Grains, etc.

Fearing lost of lives self alongwith my families fled to IGAR South, Mantripukhri and later on transported to Kangpokpi District, Manipur and as of now me and my family stayed at Saik Village, under Kangpokpi District, Manipur.

Due to lack of legal knowlegde and Since I was outside Manipur due to my wife's medical treatment I could not report the incident in time to the concern authority.

The list of properties destroyed or loss are mentioned in the **Annexure (enclosed)**.

The Approximate value of lost properties including the land valuation is calculated at about Rs. 50,40,000/- (fifty lakhs and forty thousand) only as per own assessment.

It is, therefore, requested to kindly registered a case and take necessary legal action against the culprits according to law.
