Sub: Complaint

Sir,

I am a Senior Medical Officer MHS posted on deputation at JNIMS as a Senior Resident Dept. of Physiology. After the eruption of communal violence in the state on 03/05/23 I along with my family members left our residential quarter NO. T-V, G(8)IB at Lamphel on 04/05/23 in the morning for 1st MR for safety, leaving behind all our belongings in the quarter. We remained at 1st MR for a few days and flew to Chandigarh on 08/05/23 where we remained there for some time and later shifted to Guwahati. We recently came to Churachandpur and I reported for duty to Churachandpur Medical College. However, most of my household items such as Jewelry, Sofa set, TV, RO, Gas cylinder, fridge, washing machine, Almerah, and kitchen items, etc amounting to Rs 12,00,000/(twelve lakh) have reportedly been looted/stolen by unknown miscreants from the quarter on 20/07/2023 at around 2:30 pm. I couldn't report the matter in time as I received the information late. Moreover, I and my family members were out of station during this period constantly shifting from one place to another due to various factors and could only file the complaint report when we reached my hometown, Churachandpur recently.

It is therefore requested to kindly take cognizance of the crime and take up necessary legal action against the perpetrators.
