To register Zero FIR and reports against burning and looted of house by Meitei

Sir/Madam,

I would like to state my name is Mr. Ginlianlal Vaiphei s/o Henneilam Vaiphei and Mrs. Chinneilam Vaiphei, working in CRPF and currently posted in IG, Kerala and Karnataka Sector office, Bangalore.

While I'm away from home/duty my parents stay back home alone in Langol Housing Complex, Imphal, Manipur. The house that my aged parents stay in Imphal is our own property and house is registered under my father name Shri. Henneilam Vaiphei s/o (L) Zamtinpau. As per Govt. record the old patta No. is 176/2111 and new Patta No. 1741/2679.

Unfortunately, ethnic cleansing broke out on May 05<sup>th</sup> 2023. On the very night the church that I attended was burnt down by Meitei Militants suspected to be Arambai Tengol (AT). The church that I mentioned in Langol is adjacent to World Boxing Champion Mary Kom that was probably when she came LIVE on Social Media asking the Govt. to do something about it.

As Law and Order breakdown, the Meitei Terrorist Group(s) roam freely with arms which becomes dangerous for the Kuki-Zo, Hmar, Mizo tribes to stay on. Due to which even my parents were compelled by the grave danger situation to leave our home and property and run for their lives.

In the morning of 4<sup>th</sup> May 2023 after being driven out of our house my parents run towards a CRPF camp nearby our Colony. Even while on the way to CRPF Camp for their safety they were being waylaid by God's grace they somehow managed to escape and reached the CRPF Camp. They stayed there for 5 days (4<sup>th</sup> to 9<sup>th</sup> May 2023), joining the other masses (Internally Displaced people) coming from other nearby areas too because of the State sponsored atrocities and ethnic cleansing carried out toward the Kuki-Zo-Hmar-Mizo community by the Majoritarian Meitei's.

My parents left Imphal city on 9<sup>th</sup> May 2023, navigating through long and painful journey avoiding the Meiteis mob to reach Imphal Airport for further journey to Delhi.

Till this date of submitting this FIR we have not been able to return back to our home due to this ongoing ethnic cleansing carried out by the Majoritarian, supported by the Biren Singh Govt. which is in the Chair of CM Currently. This incident has left me and my family homeless and hopeless.



On 5<sup>th</sup> August 2023, suspected to be the state sponsored Meitei Terrorist or rambai Tengol and Meitei Leepun attacked Phaipijaang or colony of Kuki-Zo-Hmar-Mizo community in Langol Housing Complex Imphal West, which is under the Lamphelpat Police Station. As confirmed by our colony member who belongs to a different community but denied to send pictures or videos of the looted and burnt house. On that day our house was completely looted, gutted and destroyed which was constructed with loan taking from SBI bank, the amount which is still not paid yet completely.

Estimated particulars cost and properties lost in our house are as below:-

- 1) Household items cost approx. 8 Lakh
  - 2) House and land estimated to be cost of 73 Lakh (Concrete building)
  - 3) Surrounding fencing and main gate cost approx. 4 lakh.
- Total cost of properties lost, cost estimated to be 85 lakh.

While waiting to gathered for the proof of our house being burnt and looted makes us delayed in submitting our FIR till now as court of justice may require proof for that specific reason which we failed to gathered as none dare to send us such proof.

Looking forward for justice, in view of the above mentioned incidents, your esteemed office is requested to kindly look into in and take necessarily action.
