

Sir,

I have the honour to state that, On 03-05-2023 at around 09:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at National Game village, Quarter No. D-27, Zone-II about 46 Km South from Saikul-PS and looted all the moveable properties and Cash including Furnitures, Utensil, Clothes and Grains etc. Due to inconvenience to report in time I was not available in the State.

The list of properties destroyed or loss are mention in the Annexure (enclosed)

The approximate value of lost property is calculated at about Rs.13.91, 990(Thirteen Lakhs Ninety one thousand and nine hundred and ninety)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
