I am to state that, On 4th May 2023 at about 3, P.M
Our locality zone I-(One) National Game Village under
Lamphei Police Station, Imphal West was under
mob attacked by some miscreants belonging to
Meitei Community with an intention to murder.
As a result, many houses and properties worth
Lakhs were destroyed.

Properties looted burnt and destroyed include:

1. Immovable properties like house having
- a) movable properties: 1. Granary and grain - 60 Kgs.
2. Furniture 3 beds and 3 Sofa sets, 3. Gas Cylinders
- ⑥ Electronic Items: Fridge, T.V. Computers, 1. Wofur
