Sir,

I have the honour to state that, on 3rd May, 2023 at around 9:00 PM some unknown miscreants belonging to Meitei Youths Organization suspected to be members of Meitei extremist **Arambai Tenggol** who are loyal group to the present **Inner MP, Shri Leishemba Sanajaoba**, World Meitei Council (WMC), Meetei Leepul and Kangleipak Kanba Lup (KKL) and Scheduled Tribe Demand Committee (STDC), **Manipur Police** and **Commandos** who take direct command from the **CM N. Biren Singh**, numbering about 1000 members carrying sophisticated weapons like AK rifles, 303 Rifles, SBBL, Pistol, Molotov, etc. with vehicles forcefully entered in my village located at **Phaipijang, Langol, Imphal West**. They looted all valuables and vandalized my house, moveable properties and leaving us homeless.

The approximate value of lost and destroyed properties are to be about **1.5 Crores**.

I, therefore, request to kindly register a regular case and take necessary legal action according to law.
