Subject :- Lodging of ~~2~~ FIR

Sir,

This is to inform you that on dated 3rd May 2023 at around 9pm a group of miscreant believed to be Shambai Tenggal, Meetei Deepun attacked our area Langol area.

However, Our family stayed at our home situated at Phaipijang Langol along with 7 (Seven) member including 3 (Three) children.

The situation became unbearable and the Assam Rifles Personnel evacuated us from there to IGAR Mantripukhei and there we detained for 4 (four) days.

Therefore, on dated 8th May 2023, many of us escorted upto Thomas Ground Kangpokpi and now staying at Kangpokpi.

Here, I like to mention that, we have left out our house with a piece of land measuring 35 x 100 sq. feet.

Approximate estimate is pointed below :-

1. Residential House worth - ₹ 1 Crore
2. Valuable approximately - ₹ 80 Lakhs
3. 2 (Two) Wheeler worth - ₹ 60,000 /

Therefore, I request you to register a case and find the Culprit and compensate me as per the law in this regard.
