With humble request, I, the undersigned applicant, beg to request you the following few words for favour of your kind consideration and necessary actions.

That I am presently working as Managing Director, M/s NM Electrical and Construction and also Partner of the Reliance JIO Infocom. Ltd. I was also formerly holding the post of General Secretary (Admn.) in one of the Oldest Regional Party of Manipur namely Manipur Peoples' Party (MPP in short) and doing philanthropic work for the welfare of the general public.

That on 19/04/2024 at about 6.20 p.m, an unknown miscreant who claim to be Project Officer of illegal Proscribed Group namely KCP MC, contact me through Whatsapp message from an unknown Mobile Number being +91 7629008730 thereby threatening me by interfering specifically in my personnel and political activity to restrain myself from campaigning on behalf of the Lok Sabha Election, 2024 Candidate namely Maheshwor Thounaojam otherwise I may be shot down with bullet. Moreover, the said unknown miscreant also further threat to attack in my resident also by planting bomb and given final last chance to face dire consequences if I failed to obey their direction (Secreenshot Copy of the Whatsapp message is also enclosed).

It may also pertinent to mention here that on earlier occasion also there were incidents of hand grenade bomb attack to my office as well as gun attack in my resident. In this regard various FIRs are also still pending before your good office. Considering to this kind of unnatural act and also in view of the present scenario of constant threat from the unknown miscreants repeatedly, I draw your kind attention to cause necessary actions so as to protect myself from such threat.

Since, they are unknown miscreant and working under the veils, I may be attack anytime and there is apprehension of attacking while moving from one place to another taking advantage of lonely places etc. That due to certain perennial threat from time to time, I have been providing house guard-cum-escort for my personal escort by the competent authorities and the same has been utilising by me from

time to time till date. However, their arms and ammunitions were withdrawn on 4/5/2023 due to the riots/ethnic clashes between Kuki Tribe and Meitei Community and as such, there is no such mean to protect my valuable life in case the unknown miscreants attacked me anytime and as such your goodself may kindly cause necessary actions for the protection of my life.

In view of the above facts and circumstances, it is therefore requested that your Goodself may kindly cause necessary actions as early as possible to protect my life as there is constant threat to my life for the likelihood of extortion and also personal attack at any moment

For this act of kindness, I shall ever remain thankful to you.
