Dear Sir,

With reference to the above cited subject, I have the honor to report to you as follows:

That, I am a Scheduled Tribe belonging to the Sukte Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act,1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our residential quarter at Qtr. No. Type-II/06, P.O/P.S Lamphel, District-Imphal West-795004 on the 4th of May,2023 at around 9:30 AM, And it has come to our knowledge that our deserted quarter was attacked, destroyed and looted by a group of radical Meetei/Meiteis suspected to be members of Arambai Tengol, and Meetei Leepun on the 26th of July, 2023 at around 9:30 PM.

The criminals broke and open my door, destroyed and looted every valuable property form my residential quarter including my Car vehicle(Amage-S-Honda) registered under the name of me bearing Regn.No.MN01G 1493 worth about Rs. 13,00,000/- (Rupees-Thirteen Lakhs) only, and my Honda Activa registered under the name of my brother Lang Za Mang, bearing Regn.No.MN06SD 4624 worth about Rs. 1,00,000/-(Rupees - One Lakh) only & Motor Bike bearing Regn.No.MN01N 6306 worth about Rs. 1,70,000/-(Rupees One Lakh Seventy Thousand) only.

That, it may be reported here that the miscreants were shouting slogans in Meetei/Meiteis language like-"LONG LIVE MEETEI/MEITEIS LAND","KILL THE KUKIS", "KILL THE SON' & DAUGHTER' OF THE KUKI TRIBES"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the Police because everyone including top officials of the Manipur Government are patronizing them and that could be done to
