Sir,

I have the honour to state that the ethnic violence that erupted between Meiteis and Kukis on 3rd May 2023 has compelled us to flee our home (residential quarter No. B/13, Zone-4) at National Games Village, Imphal. And by the last week of November, 2023 I came to learnt that all my properties were damaged/destroyed/looted completely after fleeing our home by Meitei communities suspected to be Arambai Tenggol, Meitei Leepun.

List of properties damaged/destroyed/looted with approximate cost/amount are given below:

1. Plot (82 x 63 ft) including pucca fencing -70 lakhs
2. i20 Active car bearing Regn No. MN01463- 9.5 lakhs
3. active 6G (new, no number plate)- 95 thousand
4. NV Scooter bearing Regn No. MN 2798 – 60 thousand
5. Furniture – 5 lakhs
6. Kitchenware including fridge- 3 lakhs
7. Clothing (including traditional shawls and wraparounds) – 7 lakhs
8. Tools and machinery- 70 thousand
9. Poultry (local chicken& ducks)- 50 thousand
10. 100+ flower varieties including pots – 3 lakhs
11. Home business@ charcoal briquettes- 70 thousand
12. Construction of toilets & gate at the building plot- 35 lakhs.

Therefore, I would request you kindly to admit the FIR as per rule. For your prompt action, I shall remain grateful to you.

I therefore request you to take legal action against the culprits at the earliest by registering an FIR.

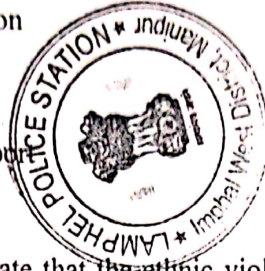
