With due respect, I the undersigned would like to lay down few lines before you for your kind consideration and necessary action. On the 4<sup>th</sup> May, 2023 at around 7am, unknown miscreant belonging to Meitei community, numbering more than 1000 people suspected to member of Arambai Tenggol, Meitei Leepun and others have attack our residence at Langol hill side Colony Opposite Langol Housing Complex Phaipijang under Imphal West district, Pin - 795004 Manipur by holding deadly weapon including. automatic rifles and bombs and we left our residence. and on 7<sup>th</sup> September the Miscreants have ransacked Loots all the properties like furniture, kitchen items, clothing, important documents. The estimated value of properties lost, ransacked by the miscreant is estimated to be 50,00,000/- Lakh: The matter could not be reported in time as well as in my concerned PS dur to the prevailing volatile situation of the state and risk of life safety. I therefore request you to kindly take necessary action in this regard for which I shall remain thankful to you.
