The estimated value of properties lost, ransacked by the miscreant is estimated to be 50,00,000/-Lakh:The matter could not be reported in time as well as in my concerned PS dur to the prevailing volatile situation of the state and risk of life safety.

I therefore request you to kindly take necessary action in this regard for which I shall remain thankful to you.
