Subject:- Report on Looting of Household items/assets, and discrimination of Schedule Tribes.

Madam,

With reference to the above cited subject I have the honour to report to you as follows:

1. That I Thanglun Minthang Gangte aged about 44 years s/o Thanglun Mangngul Gangte Beonging to the Gangte Tribe/Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a resident of PWD quarter Type-II.A-29 Lamphel, Imphal- West District Manipur. P.O. & P.S- Lamphel.
2. That at about 10:30 am on the 4th May, 2023, due to the ethnic violence in the state, I and my family have to run for our lives leaving behind our Quarter at the above mentioned address and took shelter at 86th Bn. CRPF Camp Lamphel and in the process, some unknown miscreants belonging to the majority Meitei community, have looted our Quarter including all our household items and belongings.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which maybe estimated to be Rs. 2,004,110 (Repees Twenty Lakhs Four Thousand One hundred and ten) only.
4. Fortunately, I managed to escaped from the Violence, and now currently taking refuge at Chiengkongpang Village, Churachandpur.

Reason for Delay in Reporting:

Due to the ethnic violence in the State, I and my family took shelter at the CRPF Camp, Lamphel for a few days. And from the CRPF camp, Lamphel, we again fled to Tripura and stayed at a relief camp. Due to this reason, I could not report the matter in time.

In the given circumstances, I humbly pray you kindly register FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
