Subject:- Report on vandalism, looting and burning down of properties from our rented house at Changangei Uchekon, Near Tata Motor Workshop P.O & P.S - Lamphel, District- Imphl West on 04-05-2023 around 2 pm in the evening.

Sir,

With due respect, I the undersigned would like to make a report to your good office about vandalized and looting of properties (Movable) from my rented house at Changangei Uchekon, Near Tata Motor Workshop, Lamphel, District- Imphl West on 04-05-2023 around 2 pm in the evening by Meeitei/Meitei's goons suspected to be a group of Meitei/Meetei civil personal.

At the very outset, I would like to draw few-line for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei which continues till today. On 04-05-2023 around 2 pm in the evening the door of my rented house was destroyed by Meeitei/Meitei's goons suspected to be a group of Meitei/Meetei civil personal, they vandalized, looted and burnt down all of my properties worth Rs.5,47,500/- (Rupees Five Lakh, Fourty Seven-Thousand and Five Hundred) on the said day.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future. I could not make the said report on time because from the day I run out from my resident and went to Dimapur for my life in fear of the all the person who come inside our home as they try to kill all our families members and due to the shock I got health issue in which I undergone treatment for my ailment. Thereafter, I came home at my relative resident at Hill Town, I.B Road, Churachandpur I could not reach my native place on time after running out from Imphal City for saving my life and family life.
