Subject :- Report on Looting and burning down of house, household items/assets, Documents and discrimination of Schedule Tribes.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I, **Nuzo Keivom** aged about 59 years D/o (L) **Dohrat** Belonging to the **Hmar** Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a Permanent Resident of **Hill Side Colony Langol near Lainingthouy Imphal-West District Manipur. P.O. & P.S., Lamphel**.
2. That on the 3<sup>rd</sup> of May 2023 at around 10:00 pm our locality at the above mentioned address was attacked by some unknown miscreants suspected to be a members of arambai tengol along with Meitei mob. So, in order to save ourself from the attack , I and my family have to run for our lives on the 4<sup>th</sup> of May 2023 at about 8:30 am, leaving behind our House , along with all our household items and belongings and took shelter at **Imphal Airport** . After taking shelter at the Airport for a couple of days, we managed to escaped to **Aizawl Mizoram**. in the process, some unknown miscreants from the majoritarian Community have looted our house including all our household items and belongings as well as some of our original Documents, our Jewelleries( Gold Earrings, Bracelet and Ring) and some Cash along with my daughter **Jedida Ramhlimum's** Two Wheeler Bearing Reg. No. **MNO1AN1603**, Chassis No. **ME1SG7518N0014250** And Engine No. **G3R8E0015063**
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs. 55,00,000 /-( Fifty Five Lakhs ) only**
4. Fortunately, I and my family managed to escape from the Violence, and now currently taking refuge at **Muolvaiphei Village Churachandpur** .
5. That, I am filing this information lately because there was a great danger to our life and due to which I was at different places to save my life and also due to my health related complications, I have to undergo treatment at Aizawl and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
