Sir,

On April 29, 2023, I, along with my family, (brother & sister) left our rented house at Imphal, Langol, Hebron veng, near LIC Church for family gathering at our native village i.e. Tengnoupal.

We were informed by some of our friends at Langol on 5th may 2023, that our house and properties worth Rupees Fourty Five Lakhs (Rs 4500000/-) approximately including my XUV car which I parked in the garage has been looted, vandalised and burnt down to ashes by a meitei angry mob on may 4, 2023 due to the violence that broke out between two communities (meitei and kuki) on 3rd may 2023.

Some of the main items are:

1. XUV-500 car Register No.MN03P6831 white colour,
2. Computer set worth 1.2 lakhs,
3. Clothes and dresses worth five lakhs,
5. Furnitures, sofa, almirah etc, worth 6 lakhs,
6. Gas cylinder 3 Nos, with 1 emty,
7. Kitchen wares worth 1.5 lakhs,
8. One washing machine,
9. One Refrigerator
10. books, fan etc, etc
