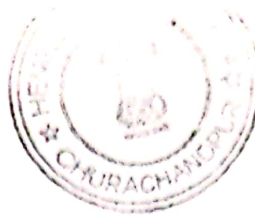

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Any Kuki Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of Shangkai Village, P.O. & P.S.- Litan, district- Ukhrul, Manipur.

That, on the *4th of May, 2023* at around *4:30 PM*, a mob of armed Meitei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun along with armed locals in and around the area attacked our village, in the process they have looted all my household items/ movable assets and vandalized my rented house owned by namely, Paokhohang Khongsai (9436810852) located at *House No. #46, Khongsai Veng, P.S.- Lamphel district- Imphal East, Manipur.* (Laiphom Khunoi)

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.25,00,000/- (Rupees Twenty-Five Lakhs) Only, inclusive of the household items / movable assets.

That, I am filing this report lately as I in remote areas for months working as a cultivator.

Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
