Subject : Zero FIR on looting and Vandalizing of properties

Sir,

With utmost regards, I have the honour to bring it to your notice that I am a permanent resident (owned) of National Game Village, near NTBC (Church).

Whereas, on 3rd May, 2023 the communal tension flare-up as obvious and thus my family (wife and children) were shifted to our acquaintance at Zone-I Quarter, NGV for safety. Later, they were sheltered at CRPF Camp adaject to the DC office at Lamphel on 4th May, 2023. As I was out of station because of my posting, I felt insecure and booked tickets for them for Delhi on 8th may, 2023 itself and thus, our family was united at Delhi and this is how we left and shun our home at National Game Village and run for our life.

After a long gap of silence, it was on January 2nd, 2024 that the gate at my house was demolished and barged in, looted and vandalized by unknown miscreants unprecedentedly. Altogether, the properties were worth Rs. 1,58,66,000/- (Rupees One Crore fifty eight lakhs sixty six thousand) only.

It is very much against the law when a particular community especially a minority or tribal like Kuki-Zo are treated without mercy and protection.

I, therefore, fervently pray to you to take up justifiable actions by filling an FIR/Zero FIR according to the laws of the land.
