That, I would like to inform and register a cognizable offence carried against me and my family at our owned house located at Paite Veng, FCI/FCS Godown Road, Sangaiprou Imphal under the jurisdiction of Lamphel Police Station, Imphal,

That, on the 3rd of May, 2023 at around 6:00 PM a huge contingent of armed radical Meetei/ Meitei suspected to be members of the Arambai Tenggol and Meetei/ Meitei Leepun attacked our village Paite Veng, in the process vandalized, looted and burnt down our house along with all the properties which may be estimated (approx.) to be Rs. 96,98,000/- (Rupees Ninety six Lakhs Ninety-Eight Thousand) as detailed below:
