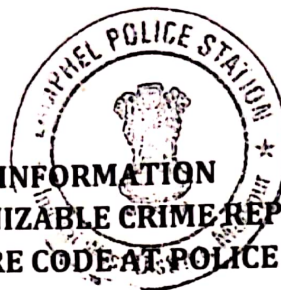

Subject: Report on Crimes of Vandalism, Looting and Arson Attack of Properties and
Discrimination of Scheduled Tribes.

Respected Sir,

With reference to the above subject, I have the honour to report to your good office as follows:
That, I Shri. Kaidavid aged about 54 years S/o Pautinlam belonging to Vaiphei tribe/ Community, a
scheduled tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection
under the SC/ST (Prevention of Atrocities) Act, 1989,

That, I would like to inform and register a cognizable offence carried against me and my family at our
owned house located at Paite Veng, FCI/FCS Godown Road, Sangai prou Imphal under the jurisdiction of Lamphel
Police Station, Imphal,

That, on the 3rd of May, 2023 at around 6:00 PM a huge contingent of armed radical Meetei/ Meitei
suspected to be members of the Arambai Tenggol and Meetei/ Meitei Leepun attacked our village Paite Veng, in
the process vandalized, looted and burnt down our house along with all the properties which may be estimated
(approx.) to be Rs. 96,98,000/- (Rupees Ninety six Lakhs Ninety-Eight Thousand) as detailed below:

me, now currently taking refuge at Gouchinkhup Veng churachandpur, P.O & P.S Churachandpur District,
Manipur.

I am filing this report lately since, I have been at different places for safety. Now, I am in a position to
file a report today. So, kindly register an FIR, investigate the matter and punish the perpetrators as per the
prevailing provisions of the laws of the land.
