

I have the honour to state that, on 04-05-2023 at around 11:00 AM, a group of unknown miscreants youths suspected to be Meitei Youths Organization of Arambai Tenggol, Meitei Leepun and Kangleipak Kanba Lup (KKL), numbering about 500 members carrying sophisticated weapons like AK-rifles and SLR entered Langol Housing Complex and started looting the properties from the houses and Quarters. In that, my Quarter located at Langol Housing Complex Type II C/37 Imphal west, PO & PS Lamphel was also broke down the door key and looted all my house hold items listed as below, I along with my family escaped from the spot, Langol and run for our life to wards Lamphel CRPF Camp near DC office Lamphel Imphal west and now taking shelter at L. Songtun Kangpokpi.
