With due respect, I beg to state you that my newly constructed residence located at Spring Villa, Phaipijaang, Langol, Imphal West, Manipur - 795 004 under Lamphel Police Station was left on 04.05.2023 after we have been attacked and run for our lives due to the start of communal crisis between the Meitei and the Kuki-Zo. Consequent upon receipt of information from reliable sources yesterday i.e. 28.12.2023, I was informed that my residence has already been ransacked, destroyed, looted and burnt my properties by unknown miscreants. My properties left behind since 4th May 2023:-
