and destruct all the furniture.

That, value of property destroyed and looted
all kind of household items estimated approximate
Rs. 35,00,000/- (Thirty five lakh only).

In this regard, you are requested to lodge Zero
FIR so that proper investigation could be done under
the law.

FIR could be reported immediately but due to
insecurity of our line and Volatile situation of the area.
