In the process, the said miscreants looted my household properties and also ransacked and damaged the house properties and the house itself.

However, I could not file a report on time as I am displaced due to the present violence and now, my family take refuge at N.Boljang Village, Kangpokpi District.

So, in light of the above cited reasons, I request your good office to kindly accept my report and register an FIR Case under relevant section of Law.
