I am to bring to your notice that on the 4th of May, 2023

Between 10.00 - 11.00 am, My residence ~~to~~ located at Thangmeiband, Neikalong, Lamphel Lampak, Imphal West was attacked by a Group of Meitei/Meitei's goons ~~numbering~~ numbering 500 to 1,000 men.

These criminals broke open my gate(s) and looted every valuable property from my ~~owned~~ Rental House, and premises worth Rupees 2,12,800+ (approx) and they burnt down all the remaining things.

Fortunately, me and my family manage to escaped from the criminals who even tried to kill or burn us alive. The delay in filling the report is due to displaced from one relief camp to another and health condition, trauma and shock due to the violence

Therefore, with utmost Respect you to take strong action against the perpetrators by registering an FIR under
