Subject- Report on vandalism, looting and burning of properties on

Sir,

I am to bring to your notice that on the 4<sup>th</sup> May at around 3:00 pm my residence  
(owned/rented) located at CPWD Quarter no. 07, Type -2, Sangaiprou, Imphal West -  
795140 was attacked, destroyed and looted by a group of Meeitei/Meiteis.

These criminals broke open my gate(s), destroyed and looted every valuable property  
from my owned house and premises worth Rupees 9,50,000 (Nine lakhs fifty thousands)  
(approx..) and the burnt down all the remaining things, including 3 (three) number of two  
wheelers vehicles, i.e. two active and one pulsar.

Therefore, with utmost respect I request you to take strong action against the  
perpetrators by registering an F.I.R under relevant sections of the Indian Penal Code. Delay  
of filling an F.I.R is due to displacement and uncertainty of place.
