With due respect, I would like to make a report to your good office about Looting and Vandalism of all my properties including my Activa 3G White Colour bearing No.MN01AC 9918, the incident took place at National Game Village, Zone1, Qtr No. B363 on 9<sup>th</sup> October 2023 at around 9pm by a group of meitei's and a member of Arambai Tengol and Meeitei Leepun looted and Vandalized my household properties.

At the very outset, I would like to draw a few line for your information that, I am a Government Employee serving as 1<sup>st</sup> IRB HAV. No. 0897078 IRB. I could not make the said report on time due to present situation which unable me to do the report. This unlawful attacked put me and my family members 2 male and 4 female in grave danger

Therefore we had fled to Vaal Veng, Churachandpur, Churachandpur District, PS Churachandpur, Manipur.

Total worth of value destroyed Rs. 19,46,000/- lakhs approx.  
I therefore seek your timely intervention and register FIR.
