Subject: Report regarding looting of two wheeler vehicle.

Sir,

With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject.

That, I would like to inform that I had been allotted a Government Quarter – Type II, No, 12 'A, RIMS, at Lamphelpat, Imphal West, PS – Lamphel. That, due to the communal clash that broke out from 3rd May, 2023, we had abandoned our government quarter for our safety and get evacuated to a safer place.

However, on 5th May, 2023, we had received information from our neighbours that on the same day at around 5:00 p.m, my residential Quarter was broke opened by unknown miscreants and my two wheeler vehicle on loan payment TVS JUPITER CLASSIC, Beaver brown colour (registration no. MN06SF3362 and Chassis no. MD62CG52M3H25479) worth Rs. 1,50000/- was looted/stolen away by the said miscreants.

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreant and help recover my stolen vehicle.

Cause of delay in reporting on time is due to my displacement and lack of legal knowledge.
