Subject : Report on vandalism, looting, burning of documents and house patta, damaged on valuable properties on moveable/immovable.

Sir,

I am here to bring to your notice that I am a resident of National Game Village, Phainom Veng, Patta No. 134 (Old), 315(New), Dak chitha No .0276 acres, PS-Lamphel, Imphal West District, Manipur.

On 4th May 2023, we left our residential house as compel due to the sudden outbreak of the ethnic violence on 3rd May, 2023 to CRPF camp, Lamphel, Imphal West District, Manipur for security reason. On 7th May, 2023 we left Imphal for Delhi by flight.

During our stayed at Delhi, It has come to our knowledge that our residential house was vandalized and burnt, looted all our valuable properties including house patta and other valuable and important documents by unknown miscreants on 4th of May, 2023 which was informed by neighbour residing near our house.

The approximate lost of properties is worth about Rs. 1,463,000/-.

The reason behind on delay in complaining is due to fleeing at Delhi on 7th May, 2023 and stayed there till February, 2024 and returned back to Manipur in Mid of March, 2024. I went for filing zero FIR at Delhi Police Station but they rejected me and told me to file at home town. So, I came to this PS to file an FIR against the culprit involved in the commission of the crime and booked him as per the law of the land.

Therefore, with utmost respect, I request you to kindly take strong action against the perpetrators by registering on FIR under relevant sections of Indian Panel Code.
