Sir,

With due respect, I would like to request your good office for taking necessary action regarding the above mentioned subject.

That, self and family lived at my allotted Government Quarter No. B-64, Zone-IV, National Games Village, Langol, Imphal West District, Manipur. However, due to the prevailing communal violence that broke out from 03-05-2023, my family was driven out from the above mentioned address on the same day by unknown Meitei miscreants. Later on, it came to our knowledge that our allotted quarter mentioned above was trespassed, looted and vandalized by the said miscreants on i.e. 04-05-2023 at around 7:00 p.m.

However, I could not file a report on time as I am displaced due to the present violence and now, my family take refuge at K.Khomunnom, Churachandpur District. Another reason for my late report is due to lack of legal knowledge. So, in light of the above cited reasons, I request your good office to kindly accept my report and register an FIR Case under relevant section of Law.
