Subject - Report on vandalism and looting of properties on Impiral West District, Manipus (movable/immovable) at my residence National Game Village, Zone-IV, B-7.

Sir.

I am to bring to your notice that on the 4th May, 2023 at around 4/5 pm, my residence (Quarter), located at National Game Village was attacked, destroyed and looted by a Group of Meetei/Meiteis radicals.

Those criminals broke open my gate, destroyed and looted every valuable property from my allotted Quarter/House, and premises worth Rupees 30 lakhs (Approx.) and they destroyed and looted all the remaining things.

While carrying out the said crime, the criminals Meitei radical groups were shouting anti-tribal slogans like, 'haothu hatlo' 'haothu chatlo', 'hatlo-hatlo'. Fearing the mob violence, I along with my family members was fleeing our house/quarter after locking all the doors and gate to 143<sup>nd</sup> Bn. CRPF, Lamphelpat.

I, therefore, with utmost respect request you to take strong actions against the perpetrators by registering FIR/Zero FIR under relevant sections of Law.

Cause of delay in reporting in time is due to my displacement.
