I have the honour to report that on 30/04/2024 at 05.00 am received a reliable information from our own source about the presence of some active cadres of PREPAK (PRO) organization in and around Lairikyengbam Makha Leikai area who are going to commit pre-judicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO Imphal West led by Inspector P. Achouba Meetei, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted cordon and search operation at some suspected houses. During the search operation at the house of Naoroibam Inaocha Singh of Lairikyengbam Makha Leikai, one person was found standing in a very suspicious manner. Due to his suspicious manner he was detained for spot verification. On body search, one Samsung Galaxy J7 Max mobile handset along with 2(two) JIO SIM cards bearing phone no. 7005188085 and 6009093196 as disclosed by him, one camouflage side bag containing 3 (three) nos. of 9mm ammunitions, 1(one) .32 ammunition, 9 (nine) nos. of blank cartridge ammunitions, 2 (two) nos. of 7.62 mm ammunitions and one driving license card was found from his possession.

On spot verification, he identified himself as Naoroibam Joyshankar Singh @ Loyumba @ Khougang (39 yrs) S/o N. Inaocha Singh of Lairikyengbam Makha Leikai. On preliminary questioning, he disclosed that he is an active cadre of PREPAK (PRO) organization and joined the said organization in the year 2009 through one Herojit from Salanthong of PREPAK (PRO) organization. Further, he revealed that he got basic military training for 3 months at Ngayensong, Myanmar and allotted Army No. 39914 of 39th batch, holding the rank of s/s Lance Corporal and presently working under the command of s/s Captain Jiten of PREPAK (PRO) organisation. He further revealed that 2 (two) nos. of 9mm pistol and 1 (one) no. of .32 pistol was handed over to one Thingom Suresh of Khurai Chaithabi Leirak to kept for sometime. Hence, he was arrested at the spot at 06:10 am and the recovered items were seized at 06:20 am from his possession by observing formalities.

Without losing much time, the said team along with the arrestee proceeded to Khurai Chaithabi Leirak after giving prior information to Imphal East District Police Control room and the team successfully detained the above mentioned person namely Thingom Suresh of Khurai Chaithabi Leirak at his house as identified by the arrestee. He identified himself as Thingom Suresh @ Boy Meitei (38 yrs) S/o. Th. Sharatchandra Meitei of Khurai Chaithabi Leirak. On preliminary questioning he disclosed that he is an active member of PREPAK (PRO) organisation and he is working under the command of Naoroibam Joyshankar of PREPAK (PRO) organisation. On asking about the pistols he further revealed that the said 2 (two) nos. of 9mm pistol along with 2 (two) nos. of magazines and 1 (one) no. of .32 pistol along with 1(one) magazine had kept concealed at the ceiling of his bed room and the said pistols was recovered at his instance. Hence, he was arrested at the spot at 06:50 am and the recovered items were seized at 07:00 am from his possession by observing formalities.

The arrested persons and the seized articles along with the seizure memo are handed over to you for taking further necessary legal action against him.
