Subject: FIR against looting of household properties and burning my residential home
at my homestead land at Langol Housing Complex, Type 3 by unknown
miscreants.

Sir,

With due respect, I would like to state the following for your kind information and
necessary action :-

That, due to the on-going conflict, we were compelled to flee our home located at my
homestead land at Langol Housing Complex Type 3, PO Lamphel, PS Lamphel, Imphal West,
Manipur unconditionally on the 3rd of May, 2023.

Unfortunately, it is also learnt from a reliable sources that all my household properties
(listed as under) were ransacked, plundered and looted by unknown miscreants believed to be
volunteers of Arambai Tenggol and Meitei Leepun in between 2nd - 15th of August, 2023.

The details of the properties looted are as follows:

King sized bed, Smart TV, Washing machine, Refrigerator, Air conditioner, Dressing
table, Rice cooker, Wooden Almirah, Steel Almirah, Oven, Iron rack, Blankets (4), Mattress,
Mosquito net, Cash (Rs. 30,000)

The total cost of properties lost is estimated to be about Rs. 3,00,000 (Rupees Three
Lakhs)

In this regard, I would like to request your good office to take up necessary action so
that I can be compensated, the culprits be caught and stringent exemplary punishment be meted
upon them.
