Unfortunately, it is also learnt from a reliable sources that all my household properties (listed as under) were ransacked, plundered and looted. Besides the notorious acts, our house has been burnt and turned into ashes by unknown miscreants believed to be volunteers of Arambai Tenggol and Meitei Leepun in between 2nd – 15th of August, 2023.

In this regard, I would like to request your good office to take up necessary action so that I can be compensated, the culprits be caught and stringent exemplary punishment be meted upon them.
