Subject: FIR against Yendrembam Premkumar and other related persons

Sir,

With due respect, I am obliged to report the following for your kind necessary action:--

1. That my son, Rajkumar Deepkanti (Naoton) is a mental patient with BPAD (Bipolar Affective Disorder). He has 80% disability (permanent) due to his mental illness, as per government-issued Unique Disability ID. He was admitted to the Existence (Halfway Home for Psycho Social Rehabilitation of Treated and Controlled Mentally Ill Persons), Changangei Uchekon, Airport Road, Imphal-795001 in July, 2023. I, along with my wife, pay regular visit to the centre to meet my son with cooked food, snacks, etc.
2. That, in our visit about fifteen days back, I observed that my son had grown suddenly thin and gloomy. He had lost interest in eating. When we asked the warden (Yendrembam Premkumar), he replied that Deepkanti was okay and ate well. From that day onwards, he had become thinner and thinner, and his cheeks had become sunken.
3. That, on the 22nd January 2024, I along with my wife visited the centre and met my son. It was about 3 pm of Imoinu day. There was no staff in the centre except the Security (Deepak). My son refused to eat anything. He cried openly with tears flowing down. He told us that he gave a chit to Birjit (male nurse) requesting family counselling. He wanted to go for home visit immediately. We immediately called the Project Director (Sarjubala) to give permission to go home, but the request was denied.
4. That, on the said day, i.e. 22nd January 2024, I tried to contact Premkumar on his phone about ten times but he didn't answer the call. Then, at about 8 pm, he called back and I immediately answered his call. On the phone, instead of talking to me, I heard Premkumar scolding and threatening my son. Then Premkumar asked me what Deepkanti had told us that day. I replied 'Nothing'.
5. That, sensing something fishy about the matter, we visited the centre the next day, i.e. 23rd January, 2024. Deepkanti insisted on going home and said that he would talk about the matter at home. So, we brought him home for home visit. So, on that and the next day, he broke down with tears several times and recounted the events, which distressed

- him greatly. We found out that my son was completely traumatized. He also talks of committing suicide because of shame.
6. That, the events which brought mental trauma to my son is narrated as follows. Sometime in 2023 (after his admission to the centre in July), Premkumar, taking advantage of his authority, coerced my son to perform nonconsensual sexual act with another inmate/patient of the centre and took video of the same on his mobile phone. It is possible that Premkumar might have repeated such atrocious deed.
 7. That, after taking video of the obscene scene, he threatened my son that he could sabotage his future marriage prospects and also his life by making the said video viral whenever he wanted. He threatened that my son should obey him without condition.
 8. That, it has come to my knowledge only this time that on the occasion of his previous admission at the centre in 2022, Premkumar allowed Deepkanti to keep his phone at the centre. Taking advantage of the feeble mind of my son, Premkumar forced Deepkanti to send money to Premkumar's friends/relatives three times from his phone. The amounts are following- Rs 4000/-, Rs 2000/- and Rs 1000/-. Premkumar is now executing his criminal plan on a larger scale.
 9. That, coming to the chain of events from 12th/13th to 22nd January 2024, Premkumar repeatedly threatened to circulate the said video as a result of which my son had come to mental breakdown and trauma. It is reliably believed that the said video had begun to circulate on or before the 22nd January, 2024 within the centre. In view of the trauma, my son had submitted a chit to Birjit on 22nd January 2024 to discuss his crisis.
 10. That, meanwhile Premkumar continued to taunt and humiliate my son. He calls my son 'Tangkhai Siba'. On the 22nd January, 2024, he said in front of other people "Eikhoi Tangkhai Siba si bank ki exam thagani hai." Birjit also mocked "Um mana pamise family counselling ne hai."
 11. That, on the 22nd January, 2024, it was confirmed that the video had become viral within the centre in one form or another. Momolata (counsellor) said to Deepkanti in the morning of 23rd January 2024 "Eingondaga oiradi khupak na on-ondana thani." Birjit also supplemented Momolata's remarks "Um nanggi khut chaoduna tharadi." Some inmates also mocked at Deepkanti on the same day.
 12. That, from the outside the Existence is a noble institution meant for psycho-social rehabilitation. However, in reality, it is practically a place of mockery, humiliation and mental torture. It is a centre that facilitates psychological trauma and moral depravity.

13. That my son's life has been traumatized and damaged. He is also having suicidal ideation. The inhuman deed has also caused trauma to his father, mother, sister and brother.

14. In view of the above-mentioned events and occurrences, you are, therefore, requested kindly to register an FIR against Yendrembam Premkumar and any other persons who were complicit in causing the psychological trauma to my son.
