Sir,

With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject that due to prevailing the communal violence that broke out from date 03/05/2023, I had kept abandoned my house located at Kwatha Khunou, Tengnoupal Dist, PS-Moreh due the threat of the violence and take shelter at Kwatha Khunjao since 29/12/2023 and left the said place on 30/12/2023. Thereafter, now taking again shelter at Lamboikhongnangkhong Releif Camp, Imphal West District, Manipur.

That, on 08/5/2023, at around 10.00 am I had went to my house to look after the condition and was found attacked, broke opened and all my properties (mentioned below) were looted by unknown miscreant belonging to Kuki Community. My household properties which were damaged and looted away by said unknown miscreants were worth Rs.7, 45000/- (Rupees, Seven Lakhs and Fourty Five Thousand).

It is therefore, requested to kindly take up necessary legal action against the unknown miscreants and help recover my stolen properties.

Cause of delaying in reporting on time is due to my displacement.
