I have the honour to state that on 08/02/2024 at about 3:00 pm received a reliable information that some unknown valley based UG groups are loitering in and around Chingmeirong area. Immediately, two teams of Lamphel PS led by Inspt. Khogendro Pangambam, OC-Lamphel PS, rushed to the said area for frisking and checking. In that unknown persons came in a very suspicious manner and tried to escape at the first sight of our police team. Immediately our police party chased and overpowered the two-unknown person at Chingmeirong near Eastern Motor Nexa Showroom at about 3:45 pm. On spot verification they identified themselves as (1) Thongram Indrajit @ Nelson (69 yrs) S/o. (L) Th. Tomba of Singjamei Mayengbam Leikai and (2) Kanjam Mohonchand (65 yrs) S/o. (L) K. Shamu of Kodompokpi Mayai Leikai.

On further verification, they stated that they are the active members of KYKL and join through one Goda of Singjamei Wangma Kongba Road since August, 2023. Now they are taking active part in the extortion of money from the general public including Hotel, Hospital, Automobile showroom etc. Accordingly, they were arrested at 4:10 pm and 4:20 pm respectively. Further seized (1) one Cellecor X301mobile handset along with Vodafone sim bearing No. 9077475258 & Jio sim bearing No. 6009452241, (2) Rs. 20,000/- (Rupees Twenty Thousand), (3) one SBI debit card issued in the name of Thongram Indrajit, (4) one The Manipur State Co-Operative Bank Ltd. debit card issued in the name of Thongram Indrajit, (5) one Manipur Old Age Pension Scheme card issued in the name of Thongram Indrajit Singh, (6) one Aadhaar Card of Thongram Indrajit Singh bearing No. 609370001427, (7) one Motor Driving Licence bearing D.L. No. 140243/UKL issued in the name of Thongram Indrajit Singh and (8) one voter card of Thongram Indrajit with voter card No. MPT0180000 from the production of Thongram Indrajit @ Nelson (69 yrs) S/o. (L) Th. Tomba of Singjamei Mayengbam Leikai under a memo in presence of witnesses. And also seized (1) one Hero Pleasure, black in colour, bearing Regn. No. MN01-R/8691 along with its key, (2) one Samsung Galaxy A12 handset along with Airtel sim bearing No. 8414925206 & Jio sim bearing No. 8837319439 and (3) one SBI debit card issued in the name of Kangjam Mohonchand Meitei from the production of Kanjam Mohonchand (65 yrs) S/o. (L) K. Shamu of Kodompokpi Mayai Leikai under a memo in presence of witnesses. On further disclosure, seized one demand letter of KYKL addressed to Mahindra Finance Bank, Chingmeirong, Imphal demanding Rs. 1,00,000/- (Rupees one lakh) only from the production of Lokhon Meitei Nameirakpam (31) S/o. N. Lakmani Singh of Heirangoithong Nameirakpam Leikai, Area Business Manager, Mahindra Finance, Imphal, under a memo in presence of witnesses.

The arrested accused persons and the seized items are handed over to you for further necessary legal action.
