In compliance with Endst. No.2/3/SP-IW/2024 dated 19/01/2024, I the undersigned am submitting herewith the necessary inquiry report in respect of genuineness of documents of the land owned by Khangabok Bazar Development Board, Khangabok and its members situated at

Village No.33-Khangabokfor taking up necessary action.

That, during the course of inquiry, visited the spot i.e. Deputy Survey & Settlement Office-I, Directorate of Settlement & Land Record, Lamphelpat, Manipur, examined a good numbers of PWs including the complainant and some employees of the Deputy Survey & Settlement Office-I, Directorate of Settlement & Land Record, Manipur very minutely and tactfully in c/w the case. On examination they all fully corroborated and supported the OE of the case. The complainant Shri Pangambam Yaitongba, S&SO-I, DSLR, Manipur stated that Directorate of Settlement & Land Records has been receiving office letters signed by the alleged accused Shri Moirangthem Ningthembi Singh (now retired) S/o M. Mani Singh of Heirok Part-1, Heituppokpi, PS- Heirok, Thoubal District, Manipur, who was serving as i/c AS&SO in Directorate of Settlement & Land Records on various dates containing forged documents of land records. The documents also contained signatures of some retired officials as well as present staff.

After verifying the enclosed documents by the complainant Pangambam Yaitongba, S&SO-I, DSLR, Manipur along with the complaint report, there is a clearly visible of erased mark/correction on the attested Register and Xerox copy of "Delivery of Possession Certificate" dated 22nd December, 1986. On minutely checking/comparison, it is also found that there is no consistency of one A. Sukumar Sharma's signature, AS&SO on the provided attested Register and Xerox copy of "Delivery of Possession Certificate".

Further, it is also found that on 31/01/2023 i.e during alleged accused person M. Ningthembi Singh's tenure when he was serving as i/c AS&SO in DSLR Manipur, he verified and certified some of the pages of Corrigendum/Correction Register 33-Khangabok 1986-87 delivered to the office of DSLR.

That, for finding out the true facts, genuineness of the documents and signatures, necessary formalities of the investigation are yet to complete. It is also required to obtain the specific signatures of the alleged accused, his associates/staffs etc and to seize all the articles which might have been used by the alleged accused and his associates to prepare the fabricated documents by using forged signatures.

In the circumstances there is an evident that the accused have committed a cognizable offence chargeable U/S 465/466/468/471/420/120-B IPC.

Therefore, request to kindly take up an FIR case upon the alleged accused Shri Moirangthem Ningthembi Singh, who was serving as i/c AS&SO in Directorate of Settlement & Land Records, Manipur and his associates by register a regular case so as to enable to complete a
