Sir,

With due regard and respect, I have the honour to state that today i.e. 19/2/2024 three civil team of Lamphel PS led by Inspector Khogendro Pangambam OC-Lamphel PS conducted special operation by parking a newly bought Honda Activa (White in Colour) without Registration number of our VDF personnel in front of RIMS Radio Therapy gate since 11:00 am inside the RIMS Campus in order to nab vehicle lifter. In that at @ 5:45 pm, 2 (two) unknown persons came in a Bajaj RE Auto-rickshaw in a very suspicious manner and parked near the said Honda Activa and one unknown person from the auto-rickshaw went near the said Honda Activa. In few seconds, the Honda Activa was unlocked by him and started up and also tried to drive the vehicle from the place. Immediately, our civil police team overpowered and apprehended the two unknown persons. Later on, they identified themselves as (1) Ajijur Rahaman (43) S/o. Rahamad Ali of Chongtham Nungei, Thoubal District and (2) Md. Quyamuddin (31) S/o. Md. Alauddin of Lilong Ataokhong Mamang Leikai.
