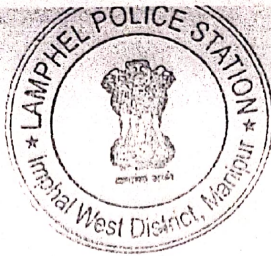

With due regards, I the undersigned have the honour to state a few line for your kind consideration and needful action.

That, on 21/1/2024 at around 3:25 pm, while my husband namely Ningthoujam Irabot Singh, aged about 42 yrs S/o N. Ibochou Singh of Khangabok Maisnam Leikai, Thoubal District, Manipur A/p Sagolband Meino Leirak, IW was coming from Sangaiprou side towards Imphal on his bicycle. Suddenly, one unknown car driven by unknown driver which was coming on the same direction had hit on the back side of his bicycle at the opposite side of Tiddim Ground, Kwakeithel, IW along Tiddim road, due to rash & negligent driving on the part of unknown driver of unknown car and fled away towards Imphal side. As a result of which, my husband received severed injury on his head and was evacuated to ASIAN Hospital for medical treatment and also the bicycle got badly damage. :
