With due respect, I. Kullai Thangchinmang, working as Sub-Inspector of Police, CID(SB), Manipur a resident of CP Quarter Type-III Number-19, Lamphelpat, Imphal West, Manipur, would like to lodge an FIR that CP Quarter Type-III Number-19, Lamphelpat, Imphal West, Manipur which is allotted to me vide Secretariat Works Department orders No. 1/42/2010-EST(W) dated 20 the July, 2011.

That, due to the ongoing ethnic conflicts between the majority Meitei/Meetei Community and the Kuki-Zomi-Mizo-Hmar community on the 3rd of May, 2023, me and my family took an emergency shelter at CRPF Camp Lamphelpat on the 4th of May 2023 due to fear of our lives and safety and thereafter, on 9th of May 2023 we were transported to Lamka, Churachandpur by an Army Convoy since then we have taken shelter at a relative's place till date.

That, after the emergency evacuation of our residential quarter mentioned above, on 1st December 2023, it came to my knowledge that some unknown persons forcefully entered my residential quarter mentioned above after breaking the lock on the entrance gate as well as the main entrance door and stayed there till date. These people broke my property, then vandalized and looted all what is within my quarter comprising of all my household items/asset etc., estimated to be at an amount of Rs 15,00,000/- (Rupees Fifteen Lakhs) only was all lost.
