



Today i.e. 24/05/2024 at 2.50 pm received a reliable information that on the same day at around 2.00 pm one Tata Tigor car, driven by unknown person coming from Sawombung side towards Imphal and one Activa ridden by unknown person which was coming from Imphal side towards Sawombung side (opposite direction) collided at Khabeisoi near Khabeisoi Oil Pump along NH-202, Imphal-Ukhrul road. As a result of which the unknown Activa rider and the pillion rider received injuries on their persons and evacuated to Hospital for medical treatment. Both the vehicles were also partly damaged.

Hence, a suo-mottu case under FIR No. 12(5)2024, LLI-PS U/S 279/338/427 IPC has been registered for investigation.

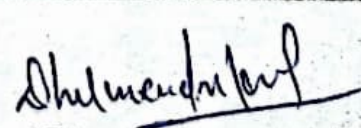
