amounting to Rs. 171,853.64 per quantity

Sir,

I have the honour to state the following few lines for your kind consideration and necessary action.

That, on 12/07/2023, a consignment containing the following items viz- (i) OTDR, Combo; MM:MTTPLUS-410 (Fault tracing device) – 4 quantities (ii) Splicer, Fusion, Single Fibre; INNO:VIEW 6L – 4 quantities belonging to Reliance Industries Ltd. were dispatched from Amingaon, Guwahati through the courier G Express Courier & Logistics Pvt. Ltd bearing Consignment No. 100415724

That, on 31/07/2023, the G Express Courier & Logistics Pvt. Ltd. courier delivered the above-referred consignment containing the said items to the office of Reliance Industries Ltd. at Mantripukhri, Imphal.

That, on 04/08/2023, upon thorough inspection of the delivered consignment by the officials of Reliance Industries Ltd. at Mantripukhri, it was discovered that out of the two items contained in the consignment, with respect to OTDR, Combo; MM:MTTPLUS-410 (Fault tracing device) – Item Code: 9500168692– amounting to Rs. 171,853.64 per quantity, only 2 quantities were delivered instead of the original 4 quantities of the said items that was dispatched from Guwahati.

That, upon thorough inquiry, it was discovered that the Imphal office of the courier G Express Courier & Logistics Pvt. Ltd had received the consignment in a torn and damaged condition, i.e - boxes containing the consignment were found to be torn and damaged. The torn and damaged condition of the boxes containing the consignment were also recorded in the CCTV footage of the office premises of the courier and a copy of the said footage is available.

That, after discovery of the fact that the 2 quantities of OTDR, Combo; MM:MTTPLUS-410 (Fault tracing device) included in the consignment were missing, a series of correspondence took place between the Office of Reliance Industries Ltd. and the courier. Thorough inquiry was conducted by both the Imphal Office of Reliance Industries Ltd. and the courier to trace/find out the missing quantities and the circumstances leading to deficient quantities. However, no conclusion could be bought upon enquiry by the parties.

In light of the facts and circumstances enumerated above, you are requested to register an FIR for necessary action.
