Subject: - Report.

Sir,

With due respect, I have the honour to state that today, i.e, 7-04-2024 at about 7.30 pm., a team of Special CDO Unit, Khabeisoi including myself and ASI Khemananda led by Subedar L. Bebekananda Singh, OC-SPL/CDO unit, Khabeisoi, conducted normal frisking checking of vehicles at Khabeisoi main entrance gate of 7<sup>th</sup> MR Imphal East. under law-and-order duty regarding upcoming Lok Sabha Election 2024. During frisking and checking at about 8.00 pm, a vehicle, Maruti car Alto Bearing Regd. No – MN01X-4811 coming from Khabeisoi side toward Imphal-Ukhrul road is stopped for frisking and checking of the vehicle. On verification of the driver and occupant of the said vehicle, they identified them self as 1) Khaying Longvah (44) S/o Joseph longvah of Sanakeithel Ukhrul District and 2) Ngahanyui Kashung (37) s/o Benjamin Kashung of Chadong village Kamjong District. On checking and searching the driver seat of the Maruti car, one plastic packet was found present concealed beneath the driver seat. So, in order to ascertain it, I have opened the plastic packet and it was found to have contained a powder which is suspected to be contraband heroine powder and on weighing of the suspected heroine powder packet, it weight about 1(one) KG(Approx) which market value is about Rs 20,00,000/- . So, I have requested the independent witnesses present there to witness the seizure of illegal drug for preparing a seizure memo in which they were reluctant and disagreed to witness the seizure to be made. Having no other option, I have seized one transparent plastic packet containing the suspected contraband heroin drugs weight about 1(one) KG(Approx) and one Maruti car Alto Regd. No – MN01X-4811 from the possession (1) Khaying Longvah and 2) Ngahanyui Kashung by preparing a seizure memo in presence of two police personnel of my team as witnesses at about 8:00 pm.

Subsequently, conducted random body searched of the detained persons, Khaying Longvah and Ngahanyui Kashung in which one mobile phone “OPPO” containing one Airtel and one JIO sim card from the body search of Khaying Longvah and again, on body search of Ngahanyui Kashung, one mobile phone “REDMI 6” containing one Airtel and one JIO sim card was found from Ngahanyui Kashung.

Seized the mobile phone “OPPO” containing one Airtel and one JIO sim card from the possession of detained person, Khaying Longvah by preparing seizure memo at about 8.05 PM and one mobile phone “REDMI 6” containing one Airtel and one JIO sim card from the possession of detained person, Ngahanyui Kashung by preparing seizure memo at about 8.10 PM.

Accordingly, arrested the two detained persons namely, (1) Khaying Longvah and 2) Ngahanyui Kashung at the spot by preparing an arrest memo at about 08:15 PM and 08.20 PM respectively.

On preliminary spot interrogation of two arrested persons, Khaying Longvah and Ngahanyui Kashung, they stated that the suspected heroin was purchased from one Hekou about 30 years of Molel Ukhrul District and Mr Ngahanyui Kashung contact for delivered at Khabeisoi to one of his associate having the contact no. 9749430895.

Subsequently, submitted a report U/S 57 ND & PS Act for the seizure of contraband drugs and arrest of the two accused persons to the Officer-in-Charge, Special CDO Unit, Khabeisoi.

The arrested persons along with the seized articles with its seizure memos, arrest memos and a copy of a report U/S 57 ND & PS Act are handed over to you for taking further necessary legal action.
