Ld. Counsel for the complainant submits that the Complainant already approached the OC/ Porompat PS and the SP/ Imphal East but no action has been taken. The petition is supported by an affidavit. Considering the allegation, I find sufficient ground for forwarding the case for investigation to OC/ Porompat.

Hence, the case is forwarded for investigation u/s 156(3) CrPC to O.C, Porompat Police Station.

The O.C/PRT-PS is directed to strictly comply with the relevant provision of law laid down in Arnesh Kumar -vs- State of Bihar (2014(8) SCALE 250) and provision of 41,41A Cr.P.C to prevent unnecessary arrest or detention.
