





Subject : Request to register FIR against the looting/plundering of
Properties and illegal occupation of my house.

Sir,

With due respect, I would like to state the following for your kind attention and necessary action.

That, I along with my family members had left our residential house at New Lambulane 2nd street, Imphal East under the jurisdiction of Porompat Police Station on the 4th May, 2023 for the safety of our life due to the ongoing ethnic crisis in Manipur. Since then, we have been not aware of the condition of my house and properties whether it remains intact or damaged/looted. However, I have been hoping that my property and house has been protected as per the order of the Hon,ble Supreme Court of India dtd 25th September, 2023 directing the state government to ensure protection of the properties of Displaced persons and prevent their encroachments, the commissioner (home), Government of Manipur had issued an order No. H-3608/2/2023-HD-HD dated the 16th October, 2023 in the name of the Hon,ble Governor of Manipur directing all relevant Deputy Commissioners and Superintendent of Police to implement the said directions of the Hon,ble Supreme Court of India

That, inspite of the above stated orders, on 18th April, 2024 I have come across in social media about rampant looting of properties in our colony (mentioned above) which went viral on social media, and on being suspicious, I have enquired the matter on my best level and finally ascertained through reliable source that the properties I have left behind were all looted and plundered by unknown miscreants in my house having Patta No. 1339 (New), Plot No. 5465/5743, Village No. 26(A)-Nongpok Inkhol under Porompat Sub-Division at New Lambulane 2nd Street, Imphal East District, Manipur. However, the exact date and time of the incident could not be ascertained. Moreover, the above said house was illegally occupied by some unknown miscreants. The approximate worth of the looted/plundered/damaged is estimated at Rs. 25,00,000/- (Twenty five lakhs) approximately.

It is therefore, requested you kindly to look into the matter and take up a necessary legal action as per the law of the land.
