




Subject: Lodging of FIR

Sir,

With due respect, I would like to state the following for your kind attention and necessary action.

That, on the 4<sup>th</sup> May, 2023 I along with my family members had left our residential house at New Lambulane 1<sup>st</sup> street, H/No. 30, Imphal East under the jurisdiction of Porompat Police Station for the safety of our life due to prevailing bloody ethnic clash between Kuki and Meitei. We were shifted to 1<sup>st</sup> MR on 5<sup>th</sup> May, 2023 and on 12<sup>th</sup> May, 2023, I along with my family members reached Kangpokpi and took shelter as displaced person in one rented house at Kangpokpi ward No. 7. Ever since from 4<sup>th</sup> May, 2023 onwards, I could not learn about my things that were left and I could not made complaint to the police.

However, on 27<sup>th</sup> April, 2024 I was informed by reliable source that on 18<sup>th</sup> April, 2024 some unknown valley-based miscreants had trespassed into my house, damaged and looted/stolen my properties which includes electronic items, furniture items, traditional ornaments, kitchen utensils, etc which worth is estimated to be about Rs 30,00,000/- (Thirty lakhs) only.

It is, therefore, requested you kindly to look into the matter and take up a necessary legal action as per the law of the land.
